Dear Parents

In the spirit of openness and transparency, I am letting you know that, at the request of Public Health England, Shoeburyness High School and Bournes Green Infant School have confirmed cases of COVID-19 and some students/children will be required to self-isolate.

In line with the guidance from Department for Education, all those in the 6th Form at Shoeburyness High School and the children in the Reception bubble in Bournes Green Infant School are required to self-isolate for fourteen days.

The rest of the household do not need to isolate unless any member of the family develops symptoms. Therefore, siblings are still able to attend school. However, we must remind parents/carers that any student/child in the groups who is isolating must not attend school, including the drop off/pick up times.

Regardless of the COVID-19 test result, the rooms, equipment and furniture in the bubbles are being thoroughly cleaned in line with the guidance.

Although it does not directly affect the vast majority of you, I felt sure that you would rather hear about it through SECAT than through some other route.

For your information, I have included the relevant section of the latest guidance we are adhering to:

- Household members of those contacts of those sent home do not need to self-isolate themselves unless the child who is self-isolating subsequently develops symptoms.
- If someone in the bubble develops symptoms themselves within the 14-day isolation period they should follow the guidance below:
